



BigHand Quantum Modules

Included in every BigHand Quantum module are source connectors to the PMS, a MS SQL BigHand Quantum data warehouse specific to the relevant module and a set of customisable dashboard templates that can be delivered using Microsoft SSRS or other dashboard providers such as Tableau or Qlik.

The table below outlines the standard dashboard templates available with each module. Custom dashboards are also available dependent on client needs at additional time/cost.
